



Export to your computer as a PDF, Excel, or CSV format.

This report has multiple tabs. The export prompt will let you select all or specific tabs. The District Summary tab is only available for district officers. Club officers will only be able to see their club.

Additionally, the export prompt will allow you to select format. PDF is the default format. Only the Club Detail tab works best for PDF. Excel works best for the remaining tabs. Excel is the recommended format.

\*\*\* **PLEASE NOTE:**

Typically, District Governors receive banners for distribution from late-October to early-November. Final calculations for banner recognitions are completed by staff after year-end giving numbers are made official.

**A Club Member On:** 'Y' indicates the person is a current club member. 'New' means the member joined within the Rotary year, and thus does not count among those members whose gifts count toward any club giving banner.

**B TRF Giving Achieved** when \$25 or more is given to any Rotary Foundation fund or grant.

- If a 'C' is listed next to the date, the Rotarian met the 2016-17 presidential citation by contributing a minimum \$26.50 to the Rotary Foundation.

**C EREY Achieved** when \$25 or more is given to the Annual Fund.

- Sustaining member is achieved when \$100 or more is given to the Annual Fund.

**D PHS Eligible Achieved** \$1,000 or more is given to the Annual Fund, PolioPlus and/or an approved Foundation Grant.
